WILLIAM D. BURRELL....

.....is Associate Professor and Director of the Executive Master of Arts Program in the Department of Criminal Justice of Temple University in Philadelphia, PA. He is a member of the faculty and directs a new Master's Degree program designed for emerging leaders in the criminal and juvenile justice systems.

In 2003, Bill retired from his position as Chief of Supervision Services in the Probation Services Division, Administrative Office of the New Jersey Courts. He was responsible for oversight and monitoring of probation services in the 21 local probation divisions, and for providing support services such as research, training, program development and technical assistance to probation administrators and staff.

Prior to joining the AOC, Bill was a probation officer in Essex County (NJ). He has bachelor's degree in sociology from Susquehanna University; and a master's degree in criminal justice from John Jay College of Criminal Justice. Bill is the co-author of Offender Assessment and Evaluation, with Todd R. Clear and Val Clear (Anderson Publishing, 1989), and a number of chapters and articles about probation. He currently serves as a member of the editorial board of Community Corrections Report and writes a bimonthly column on management issues. Bill is chairman of the Editorial Committee for *Perspectives*, the journal of the American Probation and Parole Association. He also serves as a member of APPA's Board of Directors.

Bill has developed and delivered training to managers on Performance-Based Measures for APPA in probation and parole agencies in Arizona, Georgia, Illinois, Ohio and Texas. He has consulted and conducted training on performance management for the federal probation system. He is a regular trainer at state, regional and national conferences.

Previously he served as a Supervising U.S. Probation Officer for over 27 years, during which he served as a faculty member of the Federal Judicial Center and has developed, and continues to provide training in, enhanced supervision, officer safety skills, dealing with aggressive behavior, effective communication skills, and management skills.

He also conducts training for the National Institute of Corrections (NIC) and the American Probation and Parole Association (APPA). He co-authored the 1993 NIC monograph, *New Approaches to Staff Safety*, and is the author of *New Approaches to Safe Safety-Second Edition*, released in March, 2003. He authors the "Spotlight on Safety" column for the APPA "*Perspectives*" magazine and has published numerous other articles on officer and staff safety. Bob also serves as the subject matter expert for the National Institute of Justice, "Incident Commander" simulation training website, the APPA On-Line Safety Training Program, and the APPA Audio Broadcast Safety Training Program.

Bob also conducts agency audits for NIC and has testified as an expert witness on issues relating to officer and staff safety. He is a member of the Federal Law Enforcement Officers Association, the American Society of Law Enforcement Trainers, Federal Probation & Pretrial Officers Association (FPPOA) and the American Probation and Parole Association, and serves as Chair of the associations Health and Safety Committee. He was the 1990 recipient of the Line Officer of the Year Award for the Western Region of the United States and the 1998 recipient of the Doyle Award, presented by FPPOA in recognition of his contributions to effective offender supervision issues. He was also the 2002 recipient of the Sam Houston State University Award presented by APPA "...in recognition of his outstanding contributions to scholarship in Community Corrections."
