# **Description:**

It is imperative that tribal members returning to their communities after serving time in a tribal detention facility or state/federal facility have a transition plan in place which addresses their myriad needs to facilitate successful transition, while also ensuring community and victim safety through appropriate supervision. This workshop session will discuss aspects of the Tribal Law & Order Act (TLOA) that could affect the tribes capacity to work with members returning to their community after incarceration; discuss the types of information that tribal justice agencies need to consider when making transition plans and strategies to access this information; and share information regarding the *Wisconsin Tribal Community Reintegration Program*.

## Facilitator:

*James L. Santelle* began his service as the United States Attorney for the Eastern District of Wisconsin on Monday, January 4, 2010, following his appointment by President Barack Obama on Tuesday, December 29, 2009. He has been employed by the United States Department of Justice since July of 1985. For much of that time, he has served as an Assistant United States Attorney for the Eastern District of Wisconsin, in which capacity he has prosecuted a variety of white collar, violent, and other federal crimes and litigated both affirmative and defensive actions involving the interests of the United States of America and its many agencies. Mr. Santelle has also served as the Principal Deputy Director of the Executive Office for United States Attorney for the Eastern District of Wisconsin; the Civil Division Chief in the Office of the United States Attorney for the Eastern District of Wisconsin; the Civil Division Chief for the Office of the United States Attorney for the Eastern District of Wisconsin; the Civil Division Chief for the Office of the United States Attorney in the Western District of Michigan; a Resident Legal Advisor at the United States Embassy in Baghdad; and Justice Attaché, in which capacity he was responsible for the supervision and management of virtually all Rule of Law programs and initiatives of the United States Department of Justice in Iraq. Mr. Santelle is a 1983 graduate of the University of Chicago Law School.

#### **Presenters:**

*Kimberly A. Cobb* has been a Research Associate with the American Probation & Parole Association (APPA) in Lexington, Kentucky since 2006. During this time, she has worked on a number of federally and privately funded research projects involving reentry of methamphetamine-addicted offenders and gang-affiliated offenders; development and/or enhancement of supervision strategies for underage drinking offenders, hard core drunk driving offenders, and sex offenders; and enhancing the community supervision practices of tribal probation personnel focusing on the utilization of risk assessment and related probation practices and correctional options. Among her many responsibilities are grant writing, researching justice issues, writing curricula and other publications, and delivering training and technical assistance. Her previous research-based work includes drug court implementation and outcome evaluations,

juvenile delinquency prevention program evaluations, teen court evaluations, and test validity in justice and safety training contexts.

**Richard Van Boxtel** is an enrolled member of the Oneida Tribe of Indians of Wisconsin and the Chief of Police for the Oneida Police Department in Oneida, Wisconsin. Rich began his law enforcement career at the Oneida Police Department in 1992 as a patrol officer. In 1995, he was promoted to Sergeant and has held other interim positions in the department as Lieutenant and Assistant Chief. Rich has an Associate Degree in Criminal Justice - Law Enforcement from Northeast Wisconsin Technical College, a Bachelors Degree in Public Services Administration from Silver Lake College, and a Masters Degree in Management and Organizational Behavior from Silver Lake College. Rich also serves as the Chairman for the Native American Drug and Gang Initiative in Wisconsin and as Co-Chair of the Tribal Affairs Committee for the Wisconsin Chiefs of Police Association.

*Tsyosha?aht C. Delgado* serves as the Wisconsin Tribal Community Reintegration Program Director. She is a member of the Oneida Nation and has resided in Oneida for most of her life. She is licensed as a CADC III with over 20 years experience, and has completed her Bachelors and Masters. She is an active volunteer member of the Oneida Mentorship Program, Oneida Basket Guild, O-Town Kicker's Women's Soccer Team, and a Faithkeeper for the Wolf Clan. She has worked with men and women coming out of corrections of all ages, she is knowledgeable of the Oneida Cultural and Spiritual values and ways of life and will be adopting them into the program.
