ST. LAWRENCE COUNTY PROBATION DEPARTMENT ADDITIONAL CONDITIONS RELATING TO SEX OFFENSES

Your Probation is subject to the following additional conditions:

- 1. You shall have no contact, either direct or indirect, with the victim(s) of your offense, relative to the charges brought against you, or any other persons specified by the court.
- 2. You will not be alone with any child under the age of 17 years. An adult, who is aware of your history of sexual behavior and who has been approved as a safeguard by your Probation Officer must be present.
- 3. You will not engage in sexual contact or activity with anyone under the age of 17 years.
- 4. You shall attend, participate in, successfully complete and pay for a sexual offender treatment program. Successful completion shall be determined by your counselor and your Probation Officer and will be submitted to the Court for resolution should there be a dispute as to successful completion.
- 5. You will not work or volunteer for any business or organization that provides services to or employs persons under the age of 16 years, including any youth organizations.
- 6. You will not enter adult bookstores nor purchase or possess any material(s) determined by your Probation Officer to be pornographic or sexually stimulating.
- 7. You will not use the internet or cyberspace site/chat room for pornographic, sexually stimulating conversations, or to view sexually stimulating materials.
- 8. You will not loiter or spend time at locations where persons under the age of 17 years are likely to be present, including but not limited to: parks, playgrounds, school properties, arcades, and public pools, unless you have a specific, reasonable purpose for being there.
- 9. You will not associate with or have contact with any convicted sex offender, except during your counseling sessions.
- 10. You will comply with the Sex Offender Registration Act, Article 6-C of the New York State Corrections Law and pay the \$50.00 fee to the Court.
- 11. Where the victim is under 18 years of age at the time of the offense, or you are a level 3 sex offender, you shall refrain from knowingly entering into or upon any school grounds or any other facility or institution primarily used for the care or treatment of persons under the age of 18 while one or more of such persons under the age of 18 are present, unless given written permission by your Probation Officer or the Court and the Superintendent.
- 12. Shall report to the St. Lawrence County Jail for the purpose of D.N.A. blood testing as directed by your Probation Officer and will comply with all requirements of this testing pursuant to Article 49-B of the New York State Executive Law; you shall pay the \$50.00 fee to the Court.
- 13. Shall consent to the release of the PSI to any sex offender treatment provider.
- 14. Shall submit to polygraph or Voice Analyzer, as directed by the Probation Department for purposes of treatment and supervision only.
- 15. Shall not call any "900" numbers.
- 16. Shall not operate, be employed on or dispense goods for sale at retail on a motor vehicle engages in retail sale of frozen desserts as defined in subdivision 37 of Section 375 of the Vehicle and Traffic Law.
