The American Probation and Parole Association (APPA) invites you to submit a workshop presentation proposal at its 45th Annual Training Institute. The training institute will be held in New York at the Marriott Marquis, August 23-26, 2020. APPA members and non-members are invited to submit presentation proposals for 60 and 90-minute breakout sessions.

ATTENDEES

Training institute participants include professionals in community s upervision and corrections (pretrial, probation, and parole), reentry, program and treatment providers, judiciary, criminal justice researchers and educators, addiction and co-occurring professionals, and others who are interested in the industry.

Submission Guidelines

Submissions must comply with APPA training accreditation requirements and grant credit for contact hours (e.g., social workers, substance abuse counselors, continuing legal education). All submissions are due by December 19, 2019 (no exceptions). Faculty must register for the training institute based on single day (attendance on day of workshop only) or full registration (attendance more than one day). Benefits of presenting include promotion of your name and credentials on our website, conference app, and all electronic and print marketing materials; recognition of your expertise; and networking opportunities.

Individuals in both juvenile and adult sectors from diverse organizations and disciplines are invited to submit workshop proposals. The principal goal of the training institute is to provide participants with opportunities that emphasize skill-building, increase relevant competencies, and enhance overall career development. Preference will be given to proposals which feature significant knowledge enhancement, practicing skills, activities, audience participation/interaction, and current field-related research. Presentations should offer current, relevant, and unique information and educational experiences.

PRESENTATIONS SHOULD RELATE TO ONE OR MORE OF THE FOLLOWING TOPICS:

- *Diversity and Gender:* Supervising and/ or working with multi-cultural and multigenerational workforces as well as individuals with various gender identities.
- International: Community corrections issues including but not limited to advancing practices, administrative/policy innovations, juvenile and family justice innovations, and restorative justice from a global perspective.
- *Judicial:* Working within a court system as well as policies and procedures of courts, including specialty courts, i.e., drug courts and veterans courts.
- *Juvenile Justice:* Policies, programs and issues related to juvenile facilities and court jurisdictions.
- *Local Issues:* Programs and policies specific to jurisdictions in close proximity to the training institute site.
- Leadership and Professional Development: Building leadership skills for executive and middle management.
- *Mental and Behavioral Health:* Addressing psychological conditions, issues and behaviors that impact physical and mental wellbeing.
- Officer Safety ダ Wellness: Safety for professionals in the field and office, in addition to stress management and vicarious trauma.

- *Pretrial:* Agency operations and/or the supervision of defendants prior to trial or court adjudication and in diversion programs.
- *Recidivism:* Programs focused on crime prevention and educing recidivism, as well as restorative justice.
- *Reentry:* Planning and programming for individuals released from prisons, jails or residential placement.
- *Research/Evaluation:* Presentation of data collection and analysis, evidence-based practices, outcomes, and programs.
- *Substance Abuse:* Individual and societal challenges of abuse of stimulants, depressants, opioids, etc., and substance use disorder treatment.
- *Supervision Strategies:* Agency operations and supervision or decision-making for those on community supervision, all related components such as assessments, reentry services, reporting, case planning. and interventions.
- *Technology:* Tools used for supervision, monitoring, and testing.
- *Victims' Issues:* Subjects related to restitution, victims and offenders as victims, Prison Rape Elimination Act, and Human Trafficking Prevention Act.

THE ABOVE-SUGGESTED TOPICS ARE NOT ALL-INCLUSIVE. OTHER TOPICS RELATED TO THE FIELD OF COMMUNITY SUPERVISION AND CORRECTIONS MAY BE CONSIDERED.

CALL FOR PRESENTERS



Length

Sunday (Intensive Sessions): Four (4) hour sessions *Monday and Tuesday (Workshops):* 60- or 90-minute sessions

Workshop Title

The title should be attention grabbing and identify the primary focus of the workshop. Note: APPA reserves the right to change or adjust the title of a workshop.

Workshop Description

Include a clear, concise, and accurate description of the workshop as it will appear in the program (maximum: 150 words). Note: APPA reserves the right to change the construct of a description.

Training Objectives

Describe the measurable skills and/or knowledge the attendee will gain as a result of participating, i.e., at the end of the training, participants will be able to list five of 10 causes of suicide. Also, submission must include a minimum of three training objectives.

Activity

Describe activities that will be used in the presentation. The activities will assist with selection, but will not be listed in the program. Preference will be given to presentations that are skills-based in nature, i.e., participants will be asked to complete a group activity to discuss potential steps to implement the described program at their home agency.

Faculty Information

Provide name, title, agency, address, phone, and email for all presenters and moderators. Submissions lacking any of this information will not be considered by the program committee. Panel presentations should consist of no more than four persons, including the moderator.

Resume or Vitae

Include a brief resume or vitae for each faculty member (not exceed 200 words).

Primary Contact

Submit name and contact information for person submitting proposal (see faculty information).

Presentation Benefits

Presenters will receive a discount on training institute registration and a great opportunity to network. APPA will promote the names, expertise, and credentials of each faculty via website, conference app, and electronic and print marketing materials, as appropriate. Note: APPA does not pay or reimburse presenters for expenses and fees associated with participation.
