"Ms. Cunningham brings with her the credentials of having worked in the field as an officer and the skills of an executive, both of which we were seeking in a new Executive Director," said APPA President Susan Burke.

Ms. Cunningham has a Master's Degree in Criminal Justice from Louisiana State University. She is currently the Director for New Orleans Pretrial Services, a demonstration project through the Vera Institute of Justice. She began her career as a probation and parole officer for the Louisiana Department of Public Safety. She then relocated to Texas and became the Director of Parole Services for the Texas Department of Criminal Justice. As director she led service provision to 70,000 clients and directed a staff of 2,400 in 70 offices statewide. After 17 years in Texas, she moved to Chicago to become the Director for Cook County Adult Probation where she had responsibility for a \$45 million budget and staff of 1,000.

Ms. Cunningham also has work experience as a vice president in the non-profit sector promoting successful workforce development for people with criminal records. From 2008 to 2014 she led fundraising and public policy efforts, facilitated strategic planning, secured public and private grants, and led the external communications strategy. She also had a brief stint as a national government relations director for a private company that offered a treatment protocol for individuals with alcohol and drug addictions.

"I look forward to leading the association as its strategic direction evolves to influence the national conversation about the role of community corrections in reducing our reliance on jails and prisons," said Ms. Cunningham.
