Two weeks ago, Board President Erika Preuitt and I sent a note asking you to keep our colleagues who were negatively impacted by the hurricanes in your thoughts and prayers. We've learned that countless colleagues suffered tremendous losses – homes have been completely destroyed or extensively damaged. APPA encourages all members to consider donating to the victims of Hurricane Michael and Hurricane Florence. One hundred percent of the donations will provide immediate assistance to those with the most damage or those displaced from their homes.

In Florida, 200 corrections employees completely lost their homes.
