In 2007, Darrin Dill began a campaign to develop a program to assist homeless probationers in San Francisco. The program links services from homeless shelters, mental health providers, the Sheriff's department, judges and the Public Defender's Office to attempt to transition homeless probationers from the streets into services such as housing, substance abuse, and/or health care. Within Project Outreach, Darrin Dill and his partner along with two police officers conduct weekly compliance checks on homeless probationers. He was named Bay Area Employee of the year in December 2007 and received a certificate of honor from Gavin Newsome, Mayor of San Francisco this past January. Darrin Dill's creativity and dedication as well as his efforts to both supervise and assist such a difficult caseload is deserving of this award and recognition.

As Director of the New Jersey Intensive Supervision Program (ISP) in the NJ Administrative Office of the Courts' Probation Services Division, Mr. Goldstein is responsible for managing the close monitoring of nearly 1,400 state prison releases. New Jersey's ISP has maintained a 96% employment rate and has resulted in a graduate recidivism rate under twelve percent. Harvey has been a national leader in developing victim services. He has substantially increased restitution disbursements; developed an innovative comprehensive enforcement program as an alternative to traditional court processing of collection cases; ensured victims role in sentencing, and appointed APPA's first Victim's Issues Committee. Under his directions, ISP has achieved remarkable results in collecting court-ordered restitution, fines, and financial assessments, and has produced thousands of hours of free service to the community. A former president of APPA, he has served on Advisory Boards to the Federal Bureau of Investigation, the National Institute of Justice, and the National Institute of Corrections.

Wings for L.I.F.E.—Life-skills for Inmate Families and Education is the Wings Ministry's newest program. It is a weekly empowerment/support group for the entire family offering support for the children, parents/caregivers and released inmates. Ann and her husband also lead marriage seminars in prisons for inmates and their spouses. Ann is an internationally recognized motivational speaker and frequent presenter of workshops and trainings at national and international conferences. She authored a book based on her personal life experiences, *Family Arrested: How to Survive the Incarceration of a Loved One*. Listed among important lessons learned by Wings for L.I.F.E. participants are:

- We are more alike than different
- We all need friends no matter what are lives are like
- There is a need to keep families with someone incarcerated in a family-friendly environment.
- Every step makes a difference.

Including families in the lives of those incarcerated prevents crime as it lessens the divide felt between family members when someone is away from home for long periods of time and aids in re-integration into the community upon release from prison or jail.

As West Regional Director, Mr. Porter manages three residential treatment facilities; Camp Holton, Camp Miller and Camp Kilpatrick as well as the Head Quarters camp. This award recognizes his inspirational story as portrayed in the film, *Gridiron Gang* (2006). It is a movie based on a real life documentary that was originally filmed in 1990 at Camp Kilpatrick. The movie is about a fledgling varsity level football team comprised of 15, 16 and 17 year-old young men who were sent to a probation camp by the juvenile courts in Los Angeles County. Starring as Sean Porter, Dwayne "The Rock" Johnson inspires a team of young people many had given up on to become a competitive football team. Through the game, Sean Porter teaches his players the principles of good character, strength through resiliency and genuine respect for one another. *Gridiron Gang* is a film that set out to improve community awareness in terms of what obstacles juveniles face after they are referred to probation in Los Angeles and how the dedication of one probation officer can make a difference in their lives.

## President's Award

### Maricopa County Adult Probation Department

Financial Compliance Program  
Phoenix, AZ

The Maricopa County Adult Probation Department's (MCAPD) Financial Compliance Program demonstrated innovation by successfully adapting a business model to a community corrections agency. This exemplary program benefits victims, probationers, and the community through vastly improved probationer compliance in the payment of court-ordered restitution and fees. Probationers are held accountable for payments while receiving assistance, as needed, with budgeting and employment. A key component of the program includes tracking probationers' compliance with payment orders and addressing delinquencies at specific time intervals with consistent, predictable graduated responses. Information sharing, another key component, is conducted through the department-wide Financial Compliance Committee (FCC); a monthly meeting designed to share information about various collection related issues, policy changes, resources in the community and other relevant topics. The MCAPD web-site provides employees with on demand access to resource information regarding job services and community resources; statistics on collection rates for the department and collections tips and techniques.
