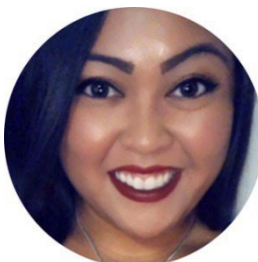
MEMBER AT LARGE | Pamerson Ifill
