List Renter agrees to indemnify and hold harmless the American Probation and Parole Association from any and all claims, damages, lawsuits, losses or exchanges, however incurred, occasioned by the use of the lists contrary to the provisions of the Agreement by List Renter or any of those referred to above.
5. It is understood and agreed that the lists have been and will be monitored to prevent improper and unauthorized use of the lists.
